## Off Licence (For Premises)



**Licence no: 15/OFF/387/2024**

### Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

**PURSUANT** to the Sale and Supply of Alcohol Act 2012, **Underproof Limited Partnership T/A Last Place** is authorised to sell alcohol on the premises situated at 54 Collingwood Street Hamilton Lake Hamilton 3204 and known as "**Last Place**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else. The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with the Act.

**CONDITIONS:** This licence is subject to the following conditions:

- a) Alcohol may be sold across the bar for off-site consumption only from 10.00am to 9.00pm, Monday to Sunday.
- b) Alcohol sales must not include:
  - i) Ready to Drink (RTD) beverages.
  - ii) Bottles of wine priced below \$20.00.
  - iii) More than 12 bottles/cans of beer per customer unless the customer is an event organiser purchasing for a large event.
  - iv) Payment by vouchers.
- c) There is to be no external advertising of alcohol products for off-site consumption.
- d) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- e) The area where alcohol is to be sold is described in the plan date stamped as received by District Licensing Committee on 9 March 2023.
- f) The bar area is designated as a supervised area (no persons under 18 can be in the area unless with their parent or legal guardian).
- g) A properly appointed certificated, acting or temporary manager must be on duty and on the premises at all times when the premises is open for the sale and supply of alcohol.
- h) A manager's register (as required by s.232 of the Act) is to be maintained and available on site.
- i) The licensee must ensure all staff receive training in their responsibilities and obligations under the Sale and Supply of Alcohol Act 2012.
- j) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be appropriate signs detailing these restrictions at every point of sale.
- k) The licensee must ensure the following are displayed;
  - i) A sign to be seen from outside the principal entrance stating the ordinary hours of business during which the premises will be open for the sale of alcohol.
  - ii) A copy of the original licence with all the conditions, just inside the principal entrance so persons entering can read it.
  - iii) A sign in a prominent place identifying the duty manager.

#### Remote Sale Conditions

- l) Alcohol may be sold remotely at any time, on any day.
- m) Alcohol must not be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day, or between 11:00pm and 6:00am the following day.
- n) The licensee must take reasonable steps to verify that the buyer and the receiver of an alcohol delivery is not under 18 years of age, and that the receiver (where present) is not intoxicated.
- o) A copy of the licence must be displayed on the Last Place internet site in a prominent place.
